TRADING WITH GABON

Intertek's Total Quality Expertise supporting
Exporters and Importers to comply with the
Conformity Assessment Programme in Gabon

Exporters/Importers trading with Gabon need to comply with the requirements of the Gabon government's office, Agence Gabonaise de Normalisation (AGANOR) Conformity Assessment Programme called Programme Gabonais d'Evaluation de la Conformite (PROGEC) in order for their goods to clear customs. Failure to do so can result in severe delays in goods clearance, penalties, or even shipments being returned. PROGEC will be enforced from 1st August 2015.

The programme in Gabon has been implemented to assure Gabon's consumers of the quality and safety of imported goods. AGANOR requires that all imports of regulated products comply with mandatory safety and related standards. Every consignment of imported regulated goods must comply with the PROGEC.

The requirements for Gabon are:

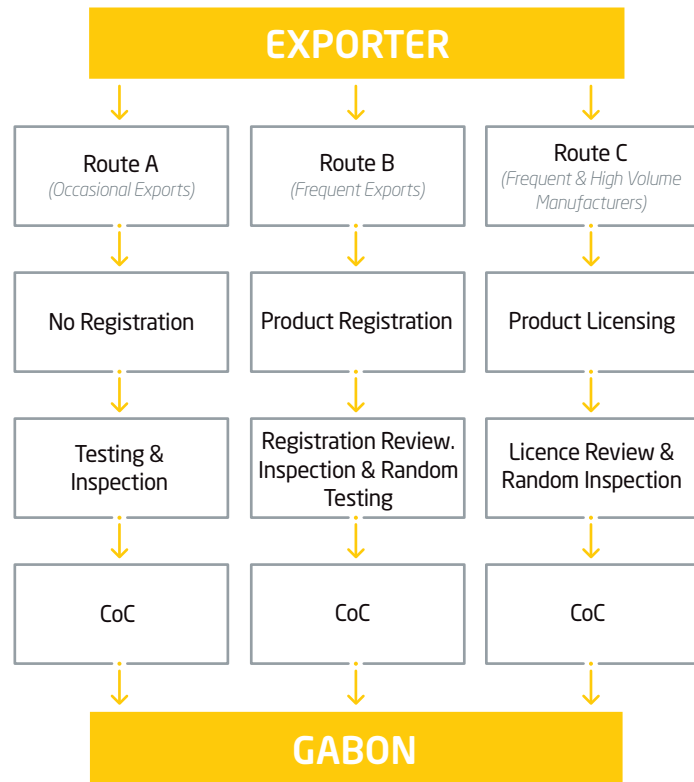
- Every consignment of imported goods must be accompanied by a Conformity Certificate. Intertek is authorised to issue these certificates.
- Certificates are needed to ensure customs clearance of shipments.
- The Certificate confirms that the products comply with the relevant Gaboni technical regulations, national, regional or international standards.
- The authorities in Gabon may take random samples from imported consignments to verify compliance.
