Conformity Assessment Programme in Tanzania

Exporters/Importers trading with Tanzania need to comply with the requirements of the Tanzania Bureau of Standards (TBS) for Customs clearance. Failure to do so can result in severe delays in goods clearance, penalties or even shipments being returned to the country of export.

The Tanzania PVoC has been implemented to assure Tanzanian consumers of the quality and safety of imported goods and to facilitate trade. 'Regulated Products' within the programme require a Certificate of Conformity which verifies, in the respective exporting countries, that the products comply with the applicable Tanzanian technical regulations and mandatory standards or approved equivalent International/National Standards.

The requirements for Tanzania PVoC

Every Shipment of imported goods which contains regulated products must be accompanied by a Certificate of Conformity (CoC) issued by your local PVoC Country Office prior to shipment.

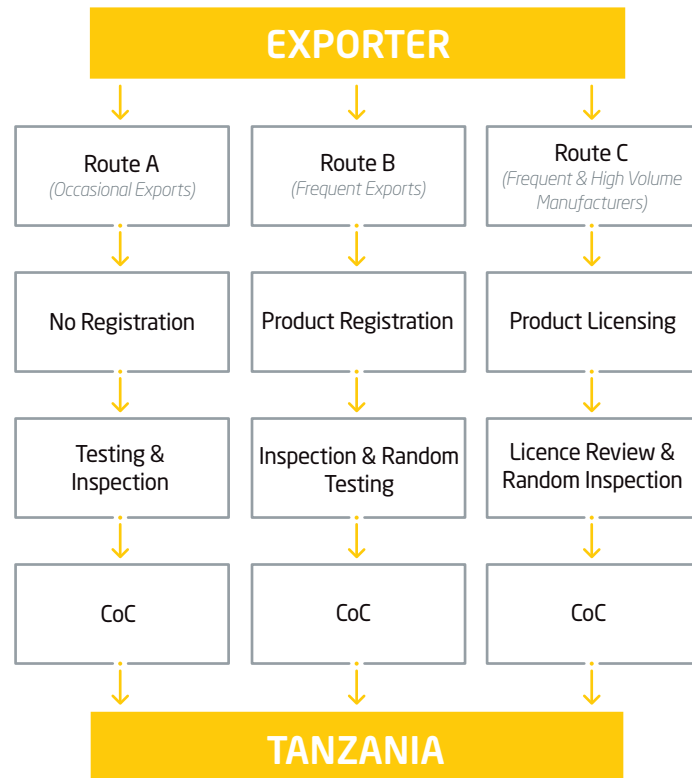
- The PVoC Certificate is required to ensure smooth Customs clearance of shipments in Tanzania.
- The PVoC Certificate confirms that the products comply with the relevant Tanzanian technical regulations and approved standards.
- The authorities in Tanzania may take random samples from imported Shipment to verify compliance.
